This Notice of Designation of Special Common Area is made and executed by CONTINENTAL HOMES OF TEXAS, L.P., a Texas limited partnership, the current "Declarant" under that certain <u>Valley Ranch Amended and Restated Master Covenant</u>, recorded as Document No. 20170028837 in the Official Public Records of Bexar County, Texas, as amended (the "Master Covenant"), and is as follows:

- 1. <u>Designation of Special Common Area</u>. Pursuant to the Master Covenant, Declarant served notice that Declarant may, from time to time, designate any interest in real property or improvements as "Special Common Area" (as defined in the Master Covenant) which benefits one or more, but less than all of the Lots, Owners or Development Areas. The property listed on <u>Exhibit "A"</u> is hereby designated as Special Common Area.
- 2. <u>Special Common Area</u>. The Special Common Area is hereby assigned and designated for the benefit of each Lot made subject, from time to time, to the terms and provisions of that certain <u>Valley Ranch Notice of Applicability of Master Covenant and Development Area Declaration [Residential] [Unit-3A, Enclave], recorded as Document No. <u>20170244219</u> Official Public Records of Bexar County, Texas (the "Benefited Lots"). The Benefited Lots are subject to the levy of Special Common Area Assessments pursuant to Section 5.5 of the Master Covenant for the estimated expenses to be incurred by the Association to maintain, repair, and manage the Special Common Area assigned herein. Declarant reserves the right, pursuant to the Master Covenant, to add additional Lots to the Benefited Lots.</u>
- 3. <u>Miscellaneous</u>. This notice constitutes a notice of designation of special common area under the Master Covenant. Any capitalized terms used and not otherwise defined in this notice shall have the meanings set forth in the Master Covenant.
